**REORGANIZATION OF THE MUNICIPAL DEVELOPMENT COUNCIL OF THE
MUNICIPAL GOVERNMENT OF DOLORES, PROVINCE OF ABRA**

WHEREAS, Section 106 of the Republic Act 7160 otherwise known as Local Government Code of 1991 mandates local government units to have comprehensive multi- sectoral development plan to be initiated by its development council and approved by the Sagguniang Bayan;

WHEREAS, the creation of municipal development council is reconstituted customarily as a whole or without exception whenever major changes exist in the local administration especially if following local elections;

NOW, THEREFORE, I, CONDE T. TURQUEZA, Mayor of the Municipality of Dolores, Abra by virtue of the powers vested in me by law, do hereby order:

Section 1. Re-Organization and Composition. The Municipal Development Council (MDC) of the Municipality of Dolores, Abra is hereby reorganized and shall be composed of the following:

- a. Formulate development plans and policies;
- b. Formulate public investment programs;
- c. Appraise and prioritize programs and projects;
- d. Formulate investment incentives;
- e. Coordinate, monitor and evaluate implementation of development programs and projects;

Section 3. Executive Committee. The Executive Committee of the MDC shall be composed of the following:

Section 4. Duties and Functions of Executive Committee. The MDC Executive Committee shall have the following functions:

- a. Represent the MDC when it is not in session;
- b. Ensure that the MDC decisions are faithfully carried out and act on matters needing immediate attentions by the MDC
- c. Formulate plans, policies and programs based on principles and priorities laid out by MDC
